- 3. Go back to the FAFSA site and click the button Start a New FAFSA.

  ALWAYS save your work as you go. You can always come back and complete the form later.
- 4. When complete, check and then submit your report. If you discover an error later, you can log in and make corrections and resubmit.
- 5. You will receive an estimate of your award if you qualify at the end of the application process, and an estimated **EFC**, **Expected Family Contribution** (this is the estimated amount that the family/you are responsible for).
- 6. You will receive a financial letter **from your college** that will include the Pell Grant (if you qualify) and any other scholarships that you might have applied for through the college. Usually the letters are mailed in April from the college.
- 7. ANALYZE all offer letters from the colleges to determine what your final cost will be. Notify the school where you plan to attend by MAY 1.

# Experts will be available to help you complete the FAFSA \*Bring your 2017 Tax Returns\*

Items you may need before you begin:		
Driver's License (if you have one)		
Social Security Number** for yourself (and your parent, if they have one)		
Student and parent income tax returns		
Earnings statements (W-2 forms, recent pay stubs)		
Bank and investment account statements		
Records of untaxed income like Social Security, contributions to a 401(k) or tax-deferred pension.		

#### Some Common questions regarding DACA/Citizenship:

What if my parents are concerned about providing their information because of their citizenship status?

Your parents' citizenship status does not affect your eligibility for federal student aid. In fact, the FAFSA form doesn't even ask about your parents' status.

→ How should we report information about my noncitizen parents on my FAFSA® form?

Here are some tips for students with noncitizen parents:

- If your parent does not have a Social Security number (SSN), you should enter all zeroes for him or her on the FAFSA form where it asks for that information. Do NOT enter a Taxpayer Identification Number in the SSN field
- If your parent doesn't have an SSN, he or she won't be able to create an <u>FSA ID</u> (which requires an SSN) and
  therefore won't be able to sign your FAFSA form electronically. You'll need to select the option to print a
  signature page when you get to the end of the application. Print the page, have your parent sign it, and then
  mail it to the address indicated so that your FAFSA form can be processed.
- If your parent doesn't live in the U.S., select "Foreign Country" from the dropdown box for the question that
  asks about the parents' state of legal residence.
- If your parents live and file taxes in a foreign country and don't file U.S. taxes, you'll have the opportunity to
  indicate that they have filed their taxes.
  - Then, when the FAFSA form asks whether your parents filed a Puerto Rican or foreign tax return, you should select "Yes."
  - o Convert the amounts on the foreign tax return into U.S. dollars as directed by the FAFSA help and hints.
  - If your parents live in one of the Freely Associated States, they should enter the Amount of Wages Earned from their Freely Associated States tax form in the field where the FAFSA form asks for adjusted gross income.
- If your parent doesn't file taxes at all, select "Not going to file" for the question that asks whether the parent(s)
  have filed taxes. Then you'll be asked for information about how much your parent earned from work, rather
  than being asked for information about specific items on the tax form.

<sup>\*\*</sup> If you are DACA, then you do NOT qualify for financial aid; your Social Security Number is for employment/work purposes only.
